The regular meeting of the City Arts and Cultural Events Committee was called to order at 7:08 p.m. November 16, 2016 at Alhambra City Hall, 111 S. First Street, Alhambra, Conference Room A.

IV. LOBBY ART UPDATE

Staff provided an updated list of artists scheduled in the Lobby of City Hall and described the upcoming February exhibit with artist David Hall who will install mandalas on one side of the room and "fierce" fantasy creatures he has created for a children's book on the other. Staff informed the Committee that Mr. Hall's reception would be held on the same night as the next CACE meeting and suggested that the committee plan to arrive a few minutes early to present a commendation certificate to him. Staff reviewed the list of the upcoming artists. Artist exhibits are scheduled in the lobby through July 2017.

V. BEVERAGE CONTAINER ART CONTEST

Staff informed the Committee that the annual Eco Fair would take place on Sunday, April 30th. The Recycled Art contest will coincide with the Eco Fair and judging will take place at that event. The CACE Committee will judge and staff suggests that the Environmental Committee participate as judges as well. The rules and regulations were distributed for review and comment. The committee was asked to send any suggestions for changes to staff as soon as possible. The artwork displayed will be categorized by age. Each participant will be responsible for setting up their artwork. The committee discussed methods of publicizing the contest including flyers to the schools, on the City's social media, flyers at the Farmers' Market, in the Around Alhambra. The winning artwork will be on display in the City Hall Lobby during May.
