**APPROVAL OF MINUTES**

Commissioner Norrington moved to approve the Minutes of the May 4, 2017 Adjourned Regular Meeting. Seconded by Commissioner Bodeman the motion carried by unanimous vote.

**UPCOMING EVENTS**

Ms. Houghton updated the commission on upcoming events including concerts in the park, 4<sup>th</sup> of July Event at Almansor Park and movies in the park.

Ms. Armendariz requested that the times be listed on upcoming events. She asked if the City was in partnership with the company showing the movies and stated that there were not sufficient portable restrooms for the amount of people that were attending last year. Ms. Armendariz requested that the volume on the movies be lowered since it is the park patrons that are being entertained and not the surrounding neighborhood.

Commissioner Seto asked what was being done about transportation and parking for the 4<sup>th</sup> of July event at Almansor Park.

Deputy Director Macias stated that staff was looking into this.

**MONTHLY STATUS REPORT**

Deputy Director Macias updated the Commission on the items listed in the report.

**ORAL COMMUNICATIONS**

Ms. Armendariz commented that in the parking lot of the Edison Easement there is an accumulation of dry leaves, trash, leaves accumulated on the walkway and graffiti on the concrete car stops. Ms. Armendariz commented that the Winter/Spring brochure indicates that

volleyball courts are available at Alhambra Park and the only thing that is on those courts are weeds. People who wish to play volleyball do so on the grass.

### **COMMISSION ORALS**

Commissioner Seto asked where the August meeting will be held.

Deputy Director Macias stated the location is Granada Park with the room to be determined.

Commissioner Barnett stated that the Memorial Day event was very well done.

Commissioner Bodeman stated his two guests were very happy with the event.

Commissioner Barnett stated that his neighbor had a brother who was a resident of Alhambra when he was killed in WWII, but his name is not on the list of those whose names are read aloud at the Memorial Day event.

Commissioner Barnett commented that when it is hot, the concrete gets very hot and he asked if some type of rubberized surface could be put around the pool area.

Ms. Houghton commented that concrete does stay cooler than other surfaces. Chemicals are used to maintain the pool and to clean and they would damage any surface other than concrete.

### **ADJOURNMENT**

Commissioner Bodeman moved to adjourn the Parks and Recreation Commission meeting. Seconded by Commissioner Norrington, the meeting was adjourned at 7:30 p.m.

Ms. Brie Houghton gave a presentation of the programs offered and a tour of the park facilities followed.
